1. ABOUT THIS POLICY

- 1.1 Brockwell Energy Limited, together with its subsidiaries and affiliates, is committed to sustainable practices that reduce environmental impact and promote a low-carbon future. - 1.5 This policy aligns with Brockwell Energy's Supply Chain & Procurement Policy, ensuring that sustainability is embedded in responsible sourcing, supplier accountability, and ethical procurement practices
